PAYMENT PLAN OPTIONS

- **Monthly Plan:** FACTS auto-draft on the 5th or 20th of the month, beginning June 2026 in 12 monthly installments
- **Semi-Annual Plan:** FACTS auto-draft twice during the year, first payment on or before June 30, 2026, with remainder due on or before January 20, 2026
- **Annual Plan:** FACTS auto-draft one time for full payment on or before June 30, 2026

ITEMS OF NOTE

- The individual who will be paying for tuition must be a FACTS Customer and set up a payment plan. If this is someone other than the enrollment responsible parent (such as a grandparent or a parent in another household), please contact the Business Office before submitting your enrollment packet.
- If your family needs a split-payment option between two households, please contact the Business Office before submitting your enrollment packet.
- Payment methods must be an auto-draft from a checking account, savings account, or credit card (with a convenience fee). Please note, if you wish to make a tuition payment by check or cash, that must be brought to the Business Office at least five business days prior to a scheduled due date to avoid automatic processing.
- All tuition payments begin in June, on the day you choose during the payment plan setup.
- Individuals receiving CHOOSE Act funds will be placed on a 10-month plan, beginning in August.



MARS HILL BIBLE SCHOOL CHOOSE ACT & OTHER OPPORTUNITIES



Mars Hill Bible School is a participating school in the Alabama Department of Revenue’s CHOOSE Act program. If you are eligible, your student may receive tuition funding of \$7,000 per school year. To be eligible for the 2026-27 school year, the student must be in grades K-12, be a resident of Alabama, and have a household income that does not exceed 300% of the federal poverty guideline for the 2025-26 tax year, available on the chart below. CHOOSE Act Timeline for 2026-2027 School Year:

- December 15, 2025 – March 31, 2026: Renewal Application window
- January 2, 2026 – March 31, 2026: New Application window
- Award notifications will be sent: April 15, 2026
- Funding of ESA funds through Class Wallet will begin: July 1, 2026

It is the responsibility of the FACTS customer to notify the MH Business Office of their application for and award of CHOOSE Act funds. Payment plans will be entered as full-price, 12-month plans, until such notification is received by the Business Office.

Discounts

Mars Hill is pleased to offer a partial tuition discount for children of full-time ministers, children of Heritage Christian University full-time students or employees, or children who have been adopted from foster care. If your family may qualify for one of these discounts, please indicate that by uploading the required documentation during the enrollment process.

Financial Aid

Mars Hill offers an internal aid program for students who qualify in grades TK – 12 th grade. Financial aid is provided by caring donors who value the importance of Christian education. All aid is needs-based, and MHBS does not offer academic or athletic scholarships.

MHBS uses FACTS Financial Aid Management to help with our tuition assistance qualifications. FACTS will provide the Mars Hill financial aid committee with an analysis. The goal of this process is to provide a fair and equitable way to provide financial aid to eligible families.

Items of Note About Financial Aid:

- Applications open on April 1, 2026.
- If you receive CHOOSE Act funding or any other discount, you are ineligible for financial aid.
- To apply for financial aid, a student must be fully reenrolled (returning students) or have received an offer of acceptance (new students).
- A \$45 per family non-refundable fee is collected by FACTS at the time of submission.
- To apply, visit: <https://online.factsmgmt.com/aid>. Returning users, log in with your existing credentials (even if you have used FACTS with a different school or program). New users, select Create an Account and enter your name, email, and password.
- You will be asked to upload tax documents and answer all application questions before an application can be considered.
- Upon approval or denial, a financial aid notice is sent to the applying family by email or paper mail.
- For more detailed information about the application process, contact the Business Office.
- Once submitted, you may log in to your FACTS user account to review the status of your application. Please allow two weeks for processing time before inquiring further about the receipt and status of the uploaded documents. If you have questions or concerns about the application process, contact a FACTS Customer Care Representative at 866-441-4637.
- Financial Aid is not automatically renewed. A new application must be submitted each year for review.
- *Please note: CHOOSE Act funds, discounts, scholarships, and financial aid are NOT stackable.*
